The software performs IFRA Matching at substance level and mixture level, using CAS number and presents a calculated table and a calculated maximum usage level per class. It calculates IFRA Batch Calculation by product, and keeps users updated on the latest IFRA standards.

Once the formulation is complete the system generates detailed reports, leaflets, labels, allergen reports and issues official IFRA Certificates.


